**AN EXECUTIVE ORDER REORGANIZING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF BAYAMBANG, AND NAMING DR. NICOLAS MIGUEL AS ITS NEW CHAIRPERSON**

**WHEREAS**, Section 43 of Republic Act No. 6975, otherwise known as the "Department of the Interior and Local Government Act of 1990," as amended by Republic Act No. 8551, mandates the establishment of a People's Law Enforcement Board (PLEB) in every city and municipality to hear and decide citizen's complaints or cases filed against officers and members of the Philippine National Police (PNP);

**WHEREAS**, the Local Chief Executive is empowered to reorganize local special bodies, including the People's Law Enforcement Board, to ensure their continued efficiency, relevance, and compliance with existing laws and policies;

**WHEREAS**, the present composition of the PLEB of Bayambang, Pangasinan, requires reorganization to reinforce its effectiveness and responsiveness to the concerns of the public;

**WHEREAS**, Dr. Nicolas Miguel is a person of known integrity, competence, and commitment to public service, and is deemed capable of leading the PLEB in the pursuit of its mandate;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. REORGANIZATION OF THE PEOPLE'S LAW ENFORCEMENT BOARD.**

The People's Law Enforcement Board (PLEB) of Bayambang, Pangasinan, is hereby reorganized to enhance its capacity to address complaints against members of the Philippine National Police (PNP) and to promote transparency and accountability in law enforcement.

**SECTION 2. COMPOSITION OF THE REORGANIZED PLEB.**

The new composition of the PLEB shall be as follows:

- Chairperson : DR. NICOLAS MIGUEL  
(*Ret. Government Physician*)
- Members : HON. MARTIN E. TERRADO II  
(*SB Member, Committee Chairman on Public Order and Safety*)
- : MR. RODELITO F. BAUTISTA  
(*Vice-President, OIC Liga ng mga Barangay*)
