"DESIGNATING DR. RAFAEL LIMUECO SAYGO AS THE FOCAL PERSON ON THE IMPLEMENTATION OF THE ANTI-RED TAPE ACT (ARTA) IN THE MUNICIPALITY OF BAYAMBANG"

WHEREAS, Republic Act No. 9485, otherwise known as the Anti-Red Tape Act of 2007 (ARTA), as amended by Republic Act No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, mandates all government agencies, including local government units, to adopt simplified procedures and measures that promote transparency, accountability, and efficient delivery of public services;

WHEREAS, the law requires the designation of a Focal Person to lead and oversee the proper implementation of the provisions of the Anti-Red Tape Act within the local government unit;

WHEREAS, there is a need to appoint a competent and responsible individual who will coordinate, monitor, and ensure compliance with ARTA regulations and directives within the Municipality of Bayambang;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. DESIGNATION OF FOCAL PERSON.

Dr. Rafael Limueco Saygo is hereby designated as the Focal Person on the Anti-Red Tape Act (ARTA) for the Municipality of Bayambang. He shall lead the formulation and implementation of initiatives to streamline procedures, reduce bureaucratic inefficiencies, and enhance public service delivery.

SECTION 2. DUTIES AND RESPONSIBILITIES. As ARTA Focal Person, Dr. Saygo shall ensure compliance with ARTA-related policies, procedures, and deadlines; coordinate with the Anti-Red Tape Authority (ARTA) and other relevant national agencies; oversee the conduct of capacity-building activities on ARTA for municipal and barangay employees; serve as the ARTA Focal Person for **all barangays in the Municipality of Bayambang**, providing guidance and support to ensure that each barangay aligns with the standards and requirements of ARTA; submit required reports and documentation to the concerned agencies; and recommend improvements in processes and systems in line with ARTA standards.

SECTION 3. SUPPORT FROM LGU OFFICES.

All departments, offices, and personnel of the Municipality of Bayambang are hereby directed to extend full support and cooperation to Dr. Saygo in the performance of his duties as ARTA Focal Person.
