AN EXECUTIVE ORDER ADOPTING THE TRANSITORY PROVISION UNDER REPUBLIC ACT NO. 12009 IN THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN FOR AN INITIAL PERIOD OF ONE (1) YEAR, SUBJECT TO REVIEW AND POSSIBLE EXTENSION, AND DIRECTING THE CONTINUED IMPLEMENTATION OF REPUBLIC ACT NO. 9184 AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) PENDING THE ISSUANCE OF NEW STANDARD FORMS AND GUIDELINES BY THE GPPB

WHEREAS, Republic Act No. 12009, otherwise known as the “New Government Procurement Act,” was enacted to institutionalize procurement reforms to promote transparency, efficiency, competitiveness, and accountability in government procurement processes;

WHEREAS, Section 56 of RA 12009 provides for a transitory period of up to three (3) years during which procuring entities, including Local Government Units (LGUs), may continue to implement Republic Act No. 9184 or the “Government Procurement Reform Act,” and its Implementing Rules and Regulations (IRR), along with all applicable issuances of the Government Procurement Policy Board (GPPB);

WHEREAS, Section 113 of RA 12009 further mandates the GPPB and, by extension, all procuring entities, to fully implement the law within three (3) years from the approval of the new procurement standard forms;

WHEREAS, as of the issuance of this Order, the GPPB has yet to release the new standard forms and related implementing guidelines, which are necessary for the full operationalization of RA 12009;

WHEREAS, the Local Government Unit of Bayambang, Pangasinan has already continued implementing the procurement procedures and forms under RA 9184, and deems it necessary to formally adopt the transitory provision to ensure continuity and legal stability in its procurement operations;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. ADOPTION OF TRANSITORY PROVISION

The Local Government Unit of Bayambang, Pangasinan hereby adopts the transitory provision under Section 56 of Republic Act No. 12009. Accordingly, the LGU shall continue to observe and implement the procedures, standards, and forms under Republic Act No. 9184 and its IRR, including relevant issuances of the Government Procurement Policy Board (GPPB), for an initial period of one (1) year from the effectivity of RA 12009.

SECTION 2. REFERENCE TO SECTION 113 AND CONTINUED USE OF RA 9184

Pursuant to Section 113 of RA 12009, which provides a three-year transitory implementation window from the approval of new procurement standard forms, and considering that such forms have not yet been issued by the GPPB, the LGU of Bayambang shall continue utilizing the existing forms, procedures, and systems under RA 9184 until such time the GPPB releases the prescribed standard forms and guidelines under RA 12009.

SECTION 3. REVIEW AND POSSIBLE EXTENSION

Prior to the expiration of the one-year period, the LGU shall evaluate its readiness to transition to RA 12009, taking into account the issuance of implementing tools by the GPPB. If necessary and appropriate, the period of transitory implementation under RA 9184 may be extended within the allowable period prescribed by law.

SECTION 4. COVERAGE

This Order shall cover all departments, offices, and units of the Local Government Unit of Bayambang involved in procurement activities, which are hereby directed to ensure compliance with the provisions of RA 9184 and its IRR during the transitory period.

SECTION 5. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain in force until amended, superseded, or revoked, or upon full implementation of RA 12009 as determined by the GPPB.
