“AN ORDER CREATING THE MUNICIPAL LITERACY COORDINATING COUNCIL (MLCC) IN THE MUNICIPALITY OF BAYAMBANG”

WHEREAS, it is a constitutional mandate that education be made accessible to all;

WHEREAS, to achieve greater results, the Municipality of Bayambang deems it imperative the establishment of literacy implementing unit to be able to localize the national LCC's goals and objectives;

WHEREAS, there is a need to strengthen and intensify the government, non-government and private sector's efforts to deliver literacy and related interventions particularly to underserved, vulnerable, and indigent constituents;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the creation the Municipal Literacy Coordinating Council (MLCC) in the Municipality of Bayambang, as follows:

SECTION 1. COMPOSITION: The Municipal Literacy Coordinating Council is hereby constituted with the following members:

SECTION 2. FUNCTIONS. The **Municipal Literacy Coordinating Council** shall have the following functions:

1. Research, planning, management, implementation, monitoring and evaluation, advocacy and social mobilization, resource generation, and institutionalization of municipality;

2. Review and assessment of progress of programs and projects being implemented on a municipality-wide level as well as barangay-based programs and projects;
3. Generation and synthesis of feedback, insights and lessons learned from municipality-based programs and projects for transmittal to the provincial PIU, RLCC, and the LCC as inputs to national/regional/provincial/policy/directions and strategy formulation;
4. Management of funds of municipality-wide projects;
5. Resource generation, fund sourcing and facilities acquisition for municipal programs and projects;
6. Planning and actual conduct of appropriate advocacy and social mobilization, networking and linkages to ensure awareness, acceptance, and support by various publics and targets of the programs and projects; and
7. Development of the municipal database literacy continuing education.

SECTION 3. There shall be a **Technical Working Group (TWG)** to be composed of the following: Municipal Planning and Development Coordinator, Public Employment Service Officer, ALS Coordinators for District I & II and the Balik Paaralan – Out of School Youth Adults (BP-OSA) Instructional Manager of BNHS and the SK Federation President. The TWG shall extend Technical Assistance to the MLCC in the performance of its functions.

SECTION 4. SECRETARIAT. The MLCC shall be composed of the LS Monitoring Head (District I & II), BP-OSA Instructional Manager (BNHS), ALS Mobile Teacher and Municipal Planning Development Staff.

SECTION 5. Additional Members may be added as the need arises.

SECTION 6. The Sangguniang Bayan of Bayambang shall at side funds which bare necessary to carry out specific roles and responsibilities in pursuance to this order.

SECTION 7. REPEALING CLAUSE. All Executives Orders, Circulars, Memoranda and other issuances inconsistent herewith are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVELY. This Executive Order shall take effect immediately and will continue until amended or revoked.
