### EXECUTIVE ORDER NO. 42

*Series of 2025*

#### AN ORDER DESIGNATING OFFICIAL PARKING AREAS FOR FOUR-WHEEL VEHICLES, MOTORCYCLES, E-BIKES, AND PRIVATE TRICYCLES WITHIN THE VICINITY OF THE HIPAD, MUNICIPALITY OF BAYAMBANG, PANGASINAN

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," provides that every local government unit shall exercise the powers necessary for its efficient and effective governance and those which are essential to the promotion of the general welfare;

**WHEREAS**, the Municipality of Bayambang recognizes the need to ensure public safety, ease of access, and orderly flow of traffic within the vicinity of government facilities and public areas, including the HIPAD (Highway Police Assistance Desk) satellite office;

**WHEREAS**, the influx of vehicles and increasing number of motorcycles, e-bike, and private tricycle users necessitate the designation of specific and organized parking areas;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

#### SECTION 1. DESIGNATED PARKING AREAS

The following areas are hereby designated as official parking zones within the vicinity of the HIPAD:

- **For Four-Wheel Vehicles:**  
The right side of the HIPAD shall serve as the designated parking area.
- **For Motorcycles, E-bikes, and Private Tricycles:**  
The left side of the HIPAD and the area in front of the yellow building shall serve as the designated parking spaces.

#### SECTION 2. ENFORCEMENT

The Bayambang Public Order and Safety Office, in coordination with the Philippine National Police (PNP) and concerned municipal offices, is hereby directed to implement and enforce this Order. Necessary signages shall be installed and violators shall be dealt with in accordance with applicable traffic laws and ordinances.
