EXECUTIVE ORDER NO. 43

IMPOSING A TRUCK BAN ALONG THE NATIONAL ROAD FROM THE RAILWAY CROSSING OF ZONE V TO THE DIKE ROAD OF BARANGAY TELBANG, BAYAMBANG, PANGASINAN, DURING PEAK HOURS

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to adopt measures that promote the general welfare of their constituents;

WHEREAS, the national highway traversing the poblacion of Bayambang experiences regular traffic congestion, particularly during peak hours, due to the increasing volume of vehicles including large trucks;

WHEREAS, the movement of heavy trucks during peak hours impedes traffic flow and endangers pedestrians, especially in densely populated and school-adjacent areas;

WHEREAS, it is in the interest of public safety and traffic efficiency to temporarily restrict truck access to the critical portion of the national road during specific hours;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COVERAGE

A truck ban is hereby imposed along the portion of the national road from the railway crossing of Zone V to the dike road of Barangay Telbang, Bayambang, Pangasinan.

SECTION 2. DEFINITION

For purposes of this Order:

- Truck – Any motor vehicle, private or commercial, with a gross vehicle weight (GVW) of 4,500 kilograms or more, including six-wheeler and ten-wheeler trucks, container vans, and trailer trucks.
- Peak Hours – The following periods:
- Morning: 7:00 a.m. to 9:00 a.m.
- Afternoon: 4:00 p.m. to 7:00 p.m.

SECTION 3. EXEMPTIONS

The following vehicles are exempted from the truck ban:

- a. Authorized emergency and government service vehicles performing official duties;
- b. Trucks transporting perishable agricultural products, provided they have a Special Delivery Permit issued by the Office of the Municipal Mayor or the Traffic Enforcement Unit.

SECTION 4. IMPLEMENTATION

This Order shall be enforced by the Philippine National Police – Bayambang, the Traffic Enforcement Group, and other deputized personnel designated by the Municipal Mayor. Proper coordination and recording procedures shall be observed during implementation.


SECTION 5. SIGNAGE AND PUBLIC INFORMATION

The Municipal Engineer's Office shall install visible traffic signs indicating the truck ban hours and the coverage area. Information dissemination shall be undertaken to ensure public awareness.

SECTION 6. EFFECTIVITY

This Executive Order shall take effect immediately upon its issuance and dissemination.
