AN ORDER AUTHORIZING THE ECOLOGICAL SOLID WASTE MANAGEMENT OFFICE (ESWMO), THROUGH ITS OFFICER-IN-CHARGE, MR. EDUARDO M. ANGELES, JR., TO BORROW FOUR (4) DUMP TRUCKS FROM CS 1st GREEN FOR THE PURPOSE OF TRANSPORTING WASTE FROM THE ESWMO DUMP SITE TO PRIME WASTE SOLUTION PAMPANGA, INC., PORAC, PAMPANGA, FOR A PERIOD OF ONE (1) WEEK, AND DIRECTING THAT THE NECESSARY EXPENSES BE CHARGED TO THE ESWMO BUDGET

WHEREAS, the Municipality of Bayambang is committed to the efficient and environmentally-sound management of solid waste in accordance with Republic Act No. 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000";

WHEREAS, there is a need to transfer accumulated waste from the ESWMO Dump Site to Prime Waste Solution Pampanga, Inc. located in Porac, Pampanga, to ensure proper disposal and to prevent any potential public health or environmental hazard;

WHEREAS, the Ecological Solid Waste Management Office (ESWMO), through its Officer-in-Charge, Mr. Eduardo M. Angeles, Jr., has identified the need for additional logistical support in the form of a dump truck to facilitate the transfer of waste;

WHEREAS, CS 1st Green, through its President, Mr. Bernard Bawing, has agreed to lend a dump truck to the Municipality of Bayambang for said purpose;

NOW, THEREFORE, I, HON. MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1.

The Ecological Solid Waste Management Office (ESWMO), through its Officer-in-Charge, Mr. Eduardo M. Angeles, Jr., is hereby authorized to borrow four (4) dump trucks from CS 1st Green, represented by Mr. Bernard Bawing, for the purpose of transporting waste from the ESWMO Dump Site to Prime Waste Solution Pampanga, Inc., Porac, Pampanga.

SECTION 2.

The authorized use of the said dump trucks shall cover a period of one (1) week from the date of deployment.

"Baley ko, Pawilen ko, Aroen ko, tan Tulungan ko"









SECTION 3.

All necessary expenses such as gasoline and food allowance of the personnel involved in the hauling operations shall be charged to the ESWMO budget, subject to existing accounting and auditing rules and regulations.

SECTION 4.

The ESWMO is further directed to coordinate closely with CS 1st Green to ensure the proper use, care, and timely return of the dump truck and to submit a report to the Office of the Mayor upon completion of the hauling activity.

SECTION 5.

This Order shall take effect immediately.
