CREATING THE MUNICIPAL PROJECT MANAGEMENT IMPLEMENTING UNIT (MPMIU) CONSTRUCTION SUPERVISION TEAM OF THE PHILIPPINE RURAL DEVELOPMENT PROJECT SCALE-UP (PRDP-SU) IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, the Department of Agriculture has designed and implemented the Philippine Rural Development Project (PRDP) as one of the platforms for achieving the Philippine Government's Sustainable Development Goals;

WHEREAS, the PRDP is a poverty reduction development program which aims to increase rural incomes and enhance farm and fisheries productivity in the targeted areas in the Philippines;

WHEREAS, the PRDP has triggered improvements in income and food security levels of households through better targeted and sustainable agriculture and fisheries related rural development projects;

WHEREAS, given the successes and accomplishments of PRDP from its original loan and subsequent additional financing, the Government of the Philippines expanded the project to PRDP Scale Up to further support the Government's effort to improve farmers and fisherfolks access to market as well as increase income from selected agri-fishery value chains;

WHEREAS, the Municipality of Bayambang, Pangasinan is a recipient of (2) subprojects approved for funding and implementation under PRDP Scale Up which necessitate the creation of the Construction Supervision Team to ensure that project implementation is in accordance with plans and technical specifications required by the project;

SECTION 6: Duties and Functions

- a. Ensure that the construction is in accordance with plans and technical specifications and compliant to PRDP's Quality Monitoring and Durability System (QMDS).
- b. Carry out the subprojects with due diligence and efficiency, and in conformity with appropriate engineering, economic, financial, administrative, technical and agricultural practices and sound social and environmental standards, as set forth in the Operations Manual prepared and adopted by the Project.
- c. Ensure that any facilities, equipment and other property relevant to the subproject shall at all times be operated and maintained, and that all necessary repairs and renewals thereof shall be promptly made, as needed, all in accordance with social, financial, administrative and technical practices.
- d. Carry out capacity building interventions for the staff through participation and attendance in learning events subject to existing systems and procedures as prescribed in various PRDP manuals of operation.
- e. Perform other functions necessary for the effective and successful implementation of the aforementioned sub-projects.

SECTION 7: Effectivity Clause. This Executive Order shall take effect immediately and will continue until termination of the PRDP-Scale Up or until amended or revoked.
