#### AN ORDER RECONSTITUTING "OPLAN SITA" FOR THE INSPECTION AND MONITORING OF BUSINESS PERMITS IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

**WHEREAS**, the Local Government Code of 1991 (Republic Act No. 7160) mandates local government units to regulate and monitor the operations of businesses within their jurisdiction to ensure compliance with local laws and ordinances;

**WHEREAS**, ensuring that businesses within the Municipality of Bayambang operate with valid and updated business permits is essential for maintaining public order, supporting local economic development, and safeguarding consumer welfare,

**WHEREAS**, there is a need to reconstitute the task force to strengthen and sustain efforts in inspecting, verifying, and monitoring compliance with business permit requirements;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the reconstitution of "OPLAN SITA" in the Municipality of Bayambang and designate the following members of the task force:

## **SECTION 2. FUNCTIONS AND RESPONSIBILITIES**

The Task Force shall perform the following duties:

- Conduct regular inspections and monitoring of all businesses operating within the Municipality of Bayambang to ensure compliance with business permit requirements.
- Identify and document businesses operating without valid permits or those violating municipal ordinances.
- Issue warnings, notices of violation, or recommendations for sanctions as appropriate.
- Submit regular reports to the Office of the Municipal Mayor detailing the findings, actions taken, and recommendations for further action.
- Coordinate with other government agencies and offices as necessary to effectively implement the objectives of "OPLAN SITA."

## **SECTION 3. AUTHORITY TO ENFORCE**

The Task Force is hereby authorized to conduct inspections, demand presentation of business permits, and enforce applicable local ordinances and laws. Appropriate sanctions, including but not limited to fines, suspension of operations, or other penalties as provided by law, may be imposed on erring establishments.

## **SECTION 4. EFFECTIVITY**

This Executive Order shall take effect immediately upon signing and shall remain in force until revoked or amended.
