**AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE

WHEREAS, the funds allocated for the account of the **MUNICIPAL TOURISM, INFORMATION AND CULTURAL AFFAIRS OFFICE-FUEL, OIL AND LUBRICANTS EXPENSES** is insufficient to fulfill existing obligations;
