4. Submit all required documents, plans, and reports as specified in the Contract and as may be required by the Procuring Entity during the implementation of the project.
5. Coordinate with the designated representatives of the Municipality of Bayambang and the Bids and Awards Committee for oversight, monitoring, and reporting throughout the project duration.
