AN ORDER AMENDING EXECUTIVE ORDER NO. 74 SERIES 2025 ENTITLED: AN ORDER DECLARING SPECIFIC AREAS WITHIN THE MUNICIPALITY AS "DISCIPLINE ZONES," PROVIDING GUIDELINES FOR THEIR IMPLEMENTATION, CREATING AN ENFORCEMENT TEAM, ALLOCATING FUNDS, AND MANDATING THE STRICT ENFORCEMENT OF EXISTING MUNICIPAL ORDINANCES AND CORRESPONDING PENALTIES, SPECIFICALLY SECTION 4. ESTABLISHMENT OF TASK FORCE DISIPLINA (ADMINISTRATIVE & ADJUDICATION UNIT)

WHEREAS, Section 2.III of the Administrative Code of 1987 establishes that executive issuances may be amended by the same or higher executive authority to ensure continuity and legal clarity; moreover, revising an existing Executive Order typically occurs via a subsequent EO that clearly specifies the amendments, repeals, or additions;

WHEREAS, there is a recognized need to update the personnel assignments in Section 5 (Functions of Key Offices / Personnel) of Executive Order No. 74 to reflect current operational leadership;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, hereby issue the following amendments to Executive Order No. 74, Series of 2025:

SECTION 1. AMENDMENT. Section 4. ESTABLISHMENT OF TASK FORCE DISIPLINA (ADMINISTRATIVE & ADJUDICATION UNIT) of Executive Order No. 74 is hereby amended by inserting a new provision to read:

The Administrative & Adjudication Unit shall now be headed by **ATTY. RODELYNN RAJINI SAGARINO-VIDAD** as Unit Head, with **VALENTINE G. DELA CRUZ** designated as Deputy/Focal Person. **ATTY. CZARINA CHERIZZE M. DE VERA** is hereby relieved from her current designation as Head of the Administrative & Adjudication Unit and shall report back to her mother unit (Sangguniang Bayan).

SECTION 2. SAVING CLAUSE. All other provisions of Executive Order No. 74 that are not expressly amended herein shall remain in full force and effect.

SECTION 3. EFFECTIVITY. This amendment shall take effect immediately upon issuance. Publication shall be made in accordance with applicable local rules to ensure transparency and enforceability.
