AN ORDER FOR THE RECONSTITUTION OF THE TECHNICAL WORKING GROUP (TWG) IN THE LOCAL GOVERNMENT UNIT AND NUTRITION SUPPORT GROUP (NSG) IN EACH BARANGAY TO COOPERATE AND SUPPORT THE IMPLEMENTATION OF THE PHILIPPINE MULTI-SECTORAL NUTRITION PROJECT (PMNP-Like) IN BAYAMBANG, PANGASINAN.

WHEREAS, the Local Government Unit (LGU) of Bayambang recognizes the importance of addressing the nutritional needs of its constituents for their overall health and well-being which is essential in the development of our town and the nation as a whole;

WHEREAS, the Philippine Multi-sectoral Nutrition Project launched by President Ferdinand R. Marcos Jr. with the theme "Better Bodies and Minds" is a four-year project spearheaded by the Department of Health (DOH) and the Department of Social Welfare and Development (DSWD), geared towards adopting a bold multi-sectoral approach to achieve nutrition-specific and nutrition-sensitive interventions across various local government units (LGUs).

WHEREAS, the program is projected to deliver services straight to the LGUs needing intervention, in the form of primary healthcare support and nutrition services, including Early Childhood Care and Development services, on top of access to clean water and sanitation, technical information, training and financing, among other facets;

WHEREAS, it is imperative to reconstitute the technical group and a nutrition support group to strengthen the LGU's efforts in promoting nutrition in cooperation with government agencies spearheading the Philippine Multi-sectoral Nutrition Project (PMNP-Like) in addressing health in the community;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the creation of a Technical Working Group (TWG) of the LGU Bayambang and Nutrition Support Group (NSG) in each barangay of Bayambang to cooperate and support the implementation of the Philippine Multi-Sectoral Nutrition Project (PMNP-Like) in the LGU of Bayambang.

SECTION 1: COMPOSITION. The TWG shall be composed of the following members:

SECTION 2: DUTIES AND RESPONSIBILITIES. The TWG shall have the following duties and responsibilities:

1. Assist the Nutrition Support Group and lead in the implementation of Philippine Multi-Sectoral Nutrition Project (PMNP-Like) and nutrition-related programs and activities in the LGU.
2. Provide technical expertise and support in the development of nutrition policies, plans, and strategies.
3. Coordinate with relevant government agencies, non-governmental organizations, and other stakeholders in the implementation of Philippine Multi-Sectoral Nutrition Project (PMNP-Like) and all nutrition interventions.
4. Conduct assessment of the Nutrition Support Group (NSG) activities and performance for the nutritional status and needs of the community.
5. Monitor and evaluate the effectiveness of nutrition programs and initiatives in the LGU.
6. Submit regular reports and recommendations to agencies concerned regarding the status of the implementation of the Philippine Multi-Sectoral Nutrition Project (PMNP-Like) and nutrition programs and activities.

SECTION 3. MEETINGS. The TWG shall conduct its meetings regularly as agreed upon date and venue by the members. Notices of meetings shall be sent at least one (1) week before the set date.

SECTION 4. CREATION AND COMPOSITION OF NUTRITION SUPPORT GROUP. The NSG shall be composed of the following members:

Punong Barangay -----One (1) from each Barangay
Brgy. Kagawad on Health -----One (1) from each Barangay
Barangay Health Workers (BHW) -----Two (2) from each Barangay
(1 must be the BHW President)
Barangay Nutrition Scholar (BNS)-----One (1) from each Barangay
Barangay Service Point Officer (BSPO)-----One (1) from each Barangay
Barangay Kalipi President-----One (1) from each Barangay

SECTION 5. DUTIES AND RESPONSIBILITIES OF THE NUTRITION SUPPORT GROUP. The NSG shall have the following duties and responsibilities:

1. Conduct comprehensive evaluations of nutritional status and identify nutritional deficiencies, malnutrition, and other related conditions that require intervention.
2. Contribute to the implementation of policies and procedures related to the Philippine Multi-Sectoral Nutrition Project (PMNP-Like) and nutrition programs and activities.
3. Educate patients/communities about their nutritional needs, the importance of adhering to nutrition care plans, health programs of the government, and techniques for managing their nutrition at home.
4. Work closely with the TWG and other health groups to ensure a holistic approach to health care.
5. Maintain clear and effective communication within the group, with the TWG, and the communities/families, and coordinate all healthcare related actions and address any concerns.

SECTION 6. SEPARABILITY CLAUSE. If any of the above provisions is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order are hereby repealed, amended, or modified accordingly,

SECTION 8. EFFECTIVITY. This Order shall take effect immediately and will continue until amended or revoked,
