AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE OFFICE OF THE MUNICIPAL MAYOR, VICE MAYOR'S OFFICE, SANGGUNIANG BAYAN OFFICE, MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR, MUNICIPAL ACCOUNTING OFFICE, MUNICIPAL SOCIAL WELFARE & DEVELOPMENT OFFICE AND RURAL HEALTH UNIT II

WHEREAS, the funds allocated for the accounts of the OFFICE OF THE MUNICIPAL MAYOR, VICE MAYOR'S OFFICE, SANGGUNIANG BAYAN OFFICE, MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR, MUNICIPAL ACCOUNTING OFFICE, MUNICIPAL SOCIAL WELFARE & DEVELOPMENT OFFICE AND RURAL HEALTH UNIT II-PERSONNEL ECONOMIC AND RELIEF ALLOWANCE is insufficient to fulfill existing obligations;

WHEREAS, a total amount of ONE HUNDRED FIFTY FOUR THOUSAND PESOS ONLY (\$\P\$154,000.00) is available to supplement the balance in the OFFICE OF THE MUNICIPAL MAYOR, VICE MAYOR'S OFFICE, SANGGUNIANG BAYAN OFFICE, MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR, MUNICIPAL ACCOUNTING OFFICE, MUNICIPAL SOCIAL WELFARE & DEVELOPMENT OFFICE AND RURAL HEALTH UNIT II-SALARIES AND WAGES account, designated to cover the Personnel Economic and Relief Allowance of employees under the said office;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, in accordance with the authority vested in me by law as the Local Chief Executive, hereby authorize Municipal Budget Officer Marie Christine V. Bautista to execute the ONE HUNDRED FIFTY FOUR THOUSAND PESOS ONLY (\$\mathbb{P}\$154,000.00) as follows;
