**AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE
OFFICE OF THE MUNICIPAL MAYOR**

WHEREAS, the funds allocated for the account of the **OFFICE OF THE MUNICIPAL MAYOR-SEMI EXPENDABLE EXPENSES MACHINERY AND EQUIPMENT** is insufficient to fulfill existing obligations;

WHEREAS, a total amount of SIXTY THOUSAND PESOS (₱60,000.00) is available to supplement the balance in the **OFFICE OF THE MUNICIPAL MAYOR-OTHER SUPPLIES AND MATERIALS EXPENSES** account, designated for the purchase of machinery and equipment under the Municipal Treasurer's Office (centralized budget at Mayor's Office);


