## **EXECUTIVE ORDER NO. 126**

Series of 2025

AN ORDER DECLARING THE SUSPENSION OF CLASSES IN ALL LEVELS, BOTH PUBLIC AND PRIVATE SCHOOLS, IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN, ON SEPTEMBER 24, 2025, DUE TO INCLEMENT WEATHER BROUGHT ABOUT BY TYPHOON "NANDO," AND DIRECTING THE IMPLEMENTATION OF ALTERNATIVE MODES OF LEARNING, WHILE GOVERNMENT WORK SHALL CONTINUE

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers Local Chief Executives to enact measures necessary to safeguard the general welfare of their constituents;

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) has issued weather advisories warning of heavy rainfall, strong winds, and possible flooding in the Province of Pangasinan, particularly affecting the Municipality of Bayambang, due to Typhoon "NANDO";

WHEREAS, the prevailing inclement weather conditions pose serious threats to the safety and welfare of students, teachers, and the general public;

WHEREAS, there is an urgent need to suspend classes to prevent untoward incidents and to ensure the safety of learners and educators alike, while also ensuring the continuity of learning through alternative modes of delivery;


NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:


**SECTION 1. Suspension of Classes.** Classes in all levels, both in public and private schools within the territorial jurisdiction of Bayambang, Pangasinan, are hereby suspended on **September 24, 2025 (Wednesday).** 

SECTION 2. Alternative Modes of Learning. Concerned school authorities are directed to implement alternative learning modalities such as take-home assignments,

online classes, or any other appropriate distance learning strategies to ensure the continuity of education.

**SECTION 3. Government Work.** Government offices within the Municipality of Bayambang shall continue to operate and deliver essential public services. Heads of offices are directed to ensure that precautionary measures are observed for the safety of their personnel.

**SECTION 4. Dissemination.** The Public Information Office, in coordination with the Department of Education (DepEd) Bayambang District and concerned school administrators, shall ensure the widest dissemination of this Executive Order.

SECTION 5. Effectivity. This Order shall take effect immediately upon its issuance.
