AN ORDER RECONSTITUTING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) AND CHILD FRIENDLY LOCAL GOVERNANCE AUDIT (CFLGA) INTER-AGENCY MONITORING TASK FORCE (IMTF)

WHEREAS, Article 359 and 360 of the Civil Code of the Philippines provides that the government shall establish Councils for the Protection of Children;

WHEREAS, DILG Joint memorandum Circular No. 2019-01 states that the Child Friendly Local Governance Audit (CFLGA) assess Local Government Units performance in delivering child-friendly policies, programs, and services;

WHEREAS, the audit-generated data and results will serve as the basis for LGUs and NGAs to identify strengths and opportunities worth emulating and strengthen child's rights responsive governance in the country;

WHEREAS, in response to the aforementioned Memorandum Circular, it is deemed proper to create the Inter-Agency Monitoring Task Force (IMTF) or CFLGA Audit Team of the Municipality of Bayambang, Pangasinan;

WHEREAS, the MCPC has been fully harnessed to be an efficient and effective advocate of child's rights that implements all children's programs in the municipality;

WHEREAS, the CFLGA is a results-based assessment instrument, and an annual mandatory audit created to evaluate the effectiveness of LGUs in putting policies in place and implementing initiatives to improve the welfare condition of children;

WHEREAS, it is necessary to reconstitute the Municipal Council for the Protection of Children (MCPC) and the Child-Friendly Local Governance Audit (CFLGA) Inter-Agency Monitoring Task Force (IMTF), as constituted under Executive Order No. 05, Series of 2025, dated January 09, 2025, to update its membership and ensure continued effective implementation of its mandates;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as Municipal Mayor of Bayambang, hereby order the reconstituting of the Municipal Council for the Protection of Children (MCPC) and Child Friendly Local Governance Audit (CFLGA) Inter-Agency Monitoring Task Force (IMTF) of the Municipality of Bayambang with following composition and tasks;

SECTION 1. COMPOSITION. The IMTF is hereby recomposed with the following members:

CHAIRPERSON : *Municipal Local Government Operations Officer*

VICE-CHAIRPERSON : *Municipal Social Welfare and Development Officer*

SECTION 2. TASK AND RESPONSIBILITIES

1. The IMTF Chairperson shall inform and convene the Municipal LCPC of the start of the CFLGA. The IMTF shall provide an orientation to the LCPC on the CFLGA Data Capture Form (DCF) and corresponding data/documentary requirements. The LCPC concerned members should submit the data requirements to the IMTF Chairperson;
2. Upon receipt of all the data requirements, the IMTF chairperson shall convene the IMTF to accomplish the CFLGA DCF;
3. The IMTF Chairperson or Vice-Chairperson shall present the initial results of the audit to the LCPC which will serve as both a validation exercise and exit conference. The group may identify areas for improvement and technical assistance plan or request; and
4. Upon clearance and approval with the LCPC, the CFLGA DCF shall be submitted to the Provincial-IMTF. The DCF shall include supporting documents signed by all the IMTF members and noted by the Local Chief Executive (LCE).

SECTION 3. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to concerned departments/offices, barangays, MLGOO and Philippine National Police for their information and guidance.
