**REORGANIZING/ RECONSTITUTING THE MUNICIPAL DEVELOPMENT
COUNCIL OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN**

WHEREAS, under Section 106 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 as supported by DILG Memorandum No. 2001-89 dated July 2001, provides for the organization of the Local Development Councils that shall assist the Sangguniang Bayan in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

WHEREAS, the present administration is an advocate of the rule of law and has consistently complied with the above provisions and mandates of the Local Government Code of 1991, hence the Municipal Development Council must maintain, improve and develop the noble concept and principles behind its organization/ creation by providing the setting stone towards the sustainable development of the municipality.

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by the powers vested in me by law, do hereby order and direct the following:

SECTION 1. Reorganization and Reconstitution. There is a direct need to reorganize and reconstitute the Municipal Development Council of the Municipality of Bayambang, Province of Pangasinan.

SECTION 2. Composition. The reorganized and reconstituted Municipal Development Council of the Municipality of Bayambang, Pangasinan shall be composed of the following:

SECTION 3. Functions. The Municipal Development Council shall perform the following functions:

- a) Formulate long-term, medium-term, and annual socio-economic development plans and policies;
- b) Formulate the medium-term and annual public investment program;
- c) Appraise and prioritize socio-economic development programs and projects;
- d) Formulate Local Investment Incentives to promote the inflow and direction of private investment capital;
- e) Coordinate, monitor, and evaluate the implementation of development programs and projects; and
- f) Perform such other functions as may be provided by law or competent authority.

SECTION 4. Meetings and Quorum. The Municipal Development Council shall meet at least once every six (6) months or as often as may be necessary.

SECTION 5. Executive Committee. The Municipal Development Council shall create an Executive Committee to represent it and act on its behalf when it is not in session.

5.1 Composition of the Executive Committee

The Executive Committee of the Municipal Development Council shall be composed of the Municipal Mayor as Chairperson, the Committee on Appropriations of the Sangguniang Bayan, the President of the Municipal Liga ng mga Barangay, and a representative of Non-Governmental Organization that is represented in the Council, as members.

5.2 Powers and Functions of the Executive Committee of the Municipal Development Council (MDC)

- a. Ensure that the decisions of the MDC are faithfully carried out and implemented;
- b. Act on matters requiring immediate attention or action by the MDC;
- c. Formulate policies, plans, and programs based on the general principles laid down by the MDC; and
- d. Act on matters that may be authorized by the MDC.

5.3 Meetings of the Executive Committee.

The Executive Committee of the Municipal Development Council shall hold a meeting once every six (6) months or as often as may be necessary. Special meetings may be called by the Chairperson or by a majority of each member.

SECTION 6. Sectoral or Functional Committees. The Municipal Development Council may form sectoral or functional committees to assist them in the performance of their functions.

SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately.

All orders, rules and regulations, issuances, or any part coming from this office that is inconsistent with this order are hereby repealed, amended, or modified accordingly.
