**"AN ORDER REORGANIZING AND REVITALIZING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN"**

**WHREAS**, the increasing use of illegal drug has significantly contributed to the incidence of various crimes which posted threats and problems to the peace and order all over the country;

**WHEREAS**, Republic Act 9165, also known as the "Comprehensive Dangerous Act of 2002" protects the state and its individuals from the possible harms brought about by the abuse of illegal drug substances;

**WHEREAS**, the Department of Interior and Local Government (DILG) has issued various policy guidelines mandating local government units to promote peace and order, public safety transparency and accountability and implement anti- illegal drug campaigns;

**WHEREAS**, the national government in its mandate to address this pressing problem and to minimize if not eradicate the worsening drug issues, there is a need to organize a potent body at the municipal level to implement programs, projects and activities geared to the resolution of these issues to prevent and control drug abuse;

**WHEREAS**, DILG MC No. 98-127 dated December 2, 1998 provides the creation of a Municipal Anti-Drug Abuse Council to prepare an Anti-Drug Plan; implement the same at the municipal level;

**WHEREAS**, DILG MS No. 2015-63 requires the revitalization of the Anti-Drug Abuse Coordinating Councils (ADACCs) and their role in drug-clearing operations;

**WHEREAS**, the Municipality of Bayambang fully supports the efforts of National Government to suppress criminality, corruption, illegal drugs, violent extremism and other threats to peace and security down its sources nationwide;

**WHEREAS**, there is a need to reorganize the Municipal Anti-Drug Abuse Council (MADAC) to ensure the effective coordination and implementation of its programs, projects, and activities;

**NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Pangasinan, by virtue of the power vested in me by law do hereby reorganize the Municipal Anti-Drug Abuse Council (MADAC) of this municipality:

*"Baley ko, Pawilen ko, Aroen ko, tan Tulungan ko"*

**SECTION 2. Functions: The MADAC shall**

On the part of the MADAC Chairman, attest the certification declaring the "drug cleared," status of an affected barangay, certified by the Local Chief of Police and validated by the PDEA Regional Director;

1. Monitor the BADAC and BAT's names, address and other significant details, copy furnished the DILG Field Office;
2. Enjoin all Barangays to submit within the (10) days from its creation the names, address other significant details of all members of BADAC and its BADAC Auxiliary Team (BAT);
3. Receive the consolidated information report from BADAC Chair;
4. Review the consolidated reports of cluster leaders for final consolidated and submission to PDEA,
5. Maintain list of endorsement or referral of Barangay Duty Officer as to who are drug dependents for screening using the Alcohol Smoking and Substance Involvement Screening Test (ASSIST);
6. Establish one stop-shop facilities where assessment, interview, counselling, referral, processing of applications for petitions for confinement of drug dependents and PWUD who surrendered for treatment and rehabilitation and other allied processes may be undertaken;
7. Designate a focal person who shall ensure the compliance and enforcement of DDB Regulations on Voluntary Surrender of Drug Users and Dependents and shall coordinated with the appropriate service provider to assure compliance with the prescribed intervention;
8. Ensure the PWUDs who surrendered shall undergo screening in order to determine the level of risk and and/or co-morbidities and refer them to the appropriate intervention;
9. Designate certain personnel as the authorized representatives of the DDB who shall cause the processing and filing of petitions for confinement of drug dependents and WUD who surrendered for treatment and rehabilitation before the Regional Trial Courts pursuant to Sections 54 and 61 of RA 9165;
10. Organize the CADAC/MADAC Drug Reformation Committee and adopt the Program of Instructions for Drug Reformation Program;
11. Provide for the Community-Based Rehabilitation Program;
12. Lead in the formulation of the plan of action for community-based treatment and support services on the promotion and prevention of drug abuse in communities in coordination with other members of the network of LGU;
13. Monitor all (EC materials on the campaign, "Sa DROGA Talo Ka, ACHIEVE ang PAGBABAGO" to be adapted by primary care facilities in advocating for the promotion and prevention of drug abuse in communities, as approved by DOH Health Promotion and Communication Service with DOH Adapt and concurred in by DDB;
14. Submit the reports of Data on Community-Based Treatment and Rehabilitation and Data on Drug Treatment, Rehabilitation, and Aftercare of Drug Dependents thru the Anti-Drug Abuse Council Reporting System (ADAC-RS) as integrated in the Integrated Drug Monitoring and Reporting Information System (IDMRIS) of DDB;



15. The ADAC-RS Focal Persons shall:
16. Encode the necessary information on WUD who surrendered in accordance with the Community-Based Treatment and Rehabilitation Monitoring Form;
17. Ensure the monthly submission of reports;
18. Ensure the accuracy and confidentiality of data;
19. Ensure that data of all PWUD who surrendered to authorities be encoded in the system
20. In case there is no person who surrendered for the month, report the same to the DDB through email;
21. Report problems encountered in the ADAC-RS filling out the Issue Report Form;
22. Conduct advocacy and/or preventive education seminars, giving emphasis to the role of parents and children in the anti-drug campaign, ill-effects of drugs, and consequences of drug abuse. This includes the conduct of lecture on the proper procedures on rehabilitation of drug dependents and PWUD who surrendered pursuant to RA 9165 and pertinent DDB Regulations counseling program for families with drug dependents and PWUD who surrendered to cope up with trauma;
23. Designate a MADAC Secretariat, who will collate all reports and maintain periodic statistic on barangay drug-clearing operations for evaluation/ analysis and continuing enhancement of process and procedures;
24. The MADAC Secretariat shall submit all quarterly reports to the PADAC not later than the 10th day of the ensuing quarter, copy furnished the local Peace and Order Council and DILG Field Office.

### **SECTION 3. FUNDING**

The LGU shall appropriate a substantial amount of funds for anti-illegal drug-related programs, activities, and operations, such as assisting or enhancing the enforcement of RA 9165, giving priority to educational programs on drug abuse prevention and control and rehabilitation and treatment of drug dependents based on the perceived need of the locality.

### **SECTION 4. MEETINGS AND QUOROM**

The MADAC shall hold meetings as exigency requires or as the Chairman deems it necessary. Majority of the MADAC members shall be necessary to constitute a quorum in order to transact business.

### **SECTION 5. EFFECTIVITY**

This order shall take effect immediately, and shall remain in effect until renewed, modified, or revoked.
