AN ORDER RETAINING LUISITA B. DANAN AS MUNICIPAL TREASURER OF THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN, PENDING THE RELEASE OF THE DEPARTMENT OF FINANCE'S CONCURRENCE TO THE DESIGNATION OF CHARMAINE ROSE C. BULALAKAW AS ACTING MUNICIPAL TREASURER

WHEREAS, the Local Government Unit of Bayambang requires continued and uninterrupted financial management and operations to ensure the effective delivery of services to its constituents;

WHEREAS, the designation of Charmaine Rose C. Bulalakaw as Acting Municipal Treasurer is pending the concurrence of the Department of Finance (DOF);

WHEREAS, it is imperative to retain the services of the current Municipal Treasurer, Luisita B. Danan, to prevent the paralysis of LGU operations until such time as the DOF provides the necessary concurrence for the designation of Ms. Bulalakaw;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Mayor of the Municipality of Bayambang, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Retention of Municipal Treasurer. Luisita B. Danan is hereby retained as the Municipal Treasurer of Bayambang, Pangasinan, until the Department of Finance releases its concurrence to the designation of Charmaine Rose C. Bulalakaw as Acting Municipal Treasurer.

SECTION 2. Transition Period. During this transition period, Charmaine Rose C. Bulalakaw will be assigned to the Municipal Treasurer's Office to train under Luisita B. Danan, ensuring a smooth transition and continuity of operations.

SECTION 3. Assumption of Role. Upon receipt of the Department of Finance's concurrence, Charmaine Rose C. Bulalakaw shall assume the role of Acting Municipal Treasurer.

SECTION 4. Effectivity. This Executive Order shall take effect immediately and shall remain in force until the concurrence of the Department of Finance is received and Ms. Bulalakaw assumes her role as Acting Municipal Treasurer.
