AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE SPECIAL ECONOMIC ENTERPRISE

WHEREAS, the funds allocated for the account of the **SPECIAL ECONOMIC ENTERPRISE-SEMI-EXPENDABLE MACHINERY AND EQUIPMENT EXPENSES AND ACCOUNTABLE FORMS** are insufficient to fulfill existing obligations;
