REORGANIZING THE MUNICIPAL ADVISORY COUNCIL (MAC) FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM

WHEREAS, The Municipal Government of Bayambang has expressed its interest and willingness to be the partner of the Department of Social Welfare and Development for the implementation of the Pantawid Pamilyang Pilipino Program (4Ps) in the municipality.

WHEREAS, The Municipality of Bayambang has been identified as a site for the implementation of the program;

WHEREAS, Executive Order No. 25 Series of 2016 dated September 08, 2016 established the creation of the Municipal Advisory Committee (MAC) for the Pantawid Pamilyang Pilipino Program which aims for poverty reduction and empowering the poor through the provisions of health, nutrition and education services;

SECTION 2: FUNCTIONS.

1. Overseas holistic implementation of the Pantawid Pamilyang Pilipino Program ensuring fidelity to national guidelines while adapting to local needs,
2. Guarantee availability and adequacy of essential supply side services (health centres, schools, personnel)
3. Integrates Pantawid Pamilyang Pilipino Program into Bayambang's Annual Investment Plan and Local Poverty Reduction Action Plan (LPRAP) for sustained local funding.
4. Advocates for local ordinances supporting the Pantawid Pamilyang Pilipino Program and addressing local challenges.
5. Mobilize additional resources from local government units, non-government organizations (NGOs), civil society organizations (CSOs) and the private sector to support the goal and objectives of the program
6. Convene regular monthly meetings every last Wednesday of the month to address issues and plan actions
7. Serves as the primary local grievance council, resolving beneficiary complaints
8. Reviews progress reports on conditionalities and service availability, taking corrective action
9. Develops and implements a Municipal Action Plan (MAP) for active beneficiaries and Sustainability Plan for graduating beneficiaries
10. Secures regular funding for post- program services to sustain gains and prevent poverty relapse
11. Provide necessary technical assistance and logistical support for the program
12. Help promote dissemination the program to different stakeholders
13. Prepare reports with issues and concerns to be submitted to the Regional/Provincial Advisory Committee.

SECTION 3: EFFECTIVITY. This Executive Order shall take effect immediately.

All orders and regulations, issuances or any part of coming from this office that is inconsistent with this order are hereby repealed, amended or modified accordingly.
