**EXECUTIVE ORDER NO. 142**

**AN ORDER SUSPENDING CLASSES IN ALL LEVELS (BOTH PUBLIC AND PRIVATE) AND WORK IN GOVERNMENT OFFICES ON THE MUNICIPALITY OF BAYAMBANG, PANGASINAN ON OCTOBER 9, 2025 DUE TO THE EARTHQUAKE THAT STRUCK PARTS OF LUZON**

**WHEREAS**, at around 10:30 A.M. on October 9, 2025, an earthquake with Intensity No. II was recorded in Dagupan City and nearby towns, including Bayambang, as reported by the Philippine Institute of Volcanology and Seismology (DOST-PHIVOLCS);

**WHEREAS**, in the interest of ensuring the safety and welfare of students, school personnel, and government employees, the Local Government of Bayambang deems it necessary to implement precautionary measures to avoid undue risk or harm;

**WHEREAS**, Section 16 of Republic Act No. 71 otherwise known as the Local Government Code of 1991, provides that every government unit shall exercise the powers expressly granted, those necessarily therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS** pursuant to the authority vested in the undersigned as the Local Chief Executive, the temporary suspension of classes and work in government offices is hereby ordered to ensure the safety concerned;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of Bayambang Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. SUSPENSION OF CLASSES AND WORK.**

Classes in all levels, both public and private, as well as work in all municipal government offices in the Municipality of Bayambang, are hereby suspended effective October 9, 2025 (Thursday).

**SECTION 2. EXCEPTIONS.**

Offices and units involved in the delivery of basic and emergency services, disaster response, and other vital operations shall continue to render services to ensure public safety and welfare.

**SECTION 3. INFORMATION DISSEMINATION.**

The Public Information Office shall ensure the widest dissemination of this Executive Order through available media platforms.
