### EXECUTIVE ORDER NO. 145

**AN ORDER RETAINING CHARMAINE ROSE C. BULALAKAW AS ACTING HEAD OF THE INTERNAL AUDIT SERVICE OF THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN, PENDING HER OFFICIAL APPOINTMENT AS ACTING MUNICIPAL TREASURER, AND TRANSFERRING VERONICA C. GELLIDO TO THE INTERNAL AUDIT SERVICE.**

**WHEREAS**, the Local Government Unit of Bayambang requires continued and uninterrupted financial management and internal audit operations to ensure the effective delivery of services to its constituents;

**WHEREAS**, the designation of Charmaine Rose C. Bulalakaw as Acting Municipal Treasurer is pending the concurrence of the Department of Finance (DOF);

**WHEREAS**, it is necessary to retain Mrs. Bulalakaw as Acting Head of the Internal Audit Service (IAS) to maintain continuity in audit operations until her official appointment as Acting Municipal Treasurer;

**WHEREAS**, Mrs. Veronica C. Gellido shall be transferred to the Internal Audit Service to assist in its operations and shall assume the role of Acting Head of IAS only upon the official appointment of Mrs. Bulalakaw as Acting Municipal Treasurer;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Mayor of the Municipality of Bayambang, by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. Retention of Acting IAS Head.** Charmaine Rose C. Bulalakaw shall remain as the Acting Head of the Internal Audit Service until her official appointment as Acting Municipal Treasurer is confirmed by the Department of Finance.

**SECTION 2. Transfer of Personnel.** Mrs. Veronica C. Gellido shall be transferred to the Internal Audit Service to assist in its operations during the transition period.

**SECTION 3. Assumption of Role.** Upon the official appointment of Mrs. Bulalakaw as Acting Municipal Treasurer, Mrs. Veronica C. Gellido shall assume the role of Acting Head of the Internal Audit Service.

#### **SECTION 4: Effectivity**

This Executive Order shall take effect immediately and shall remain in force until such time that the Department of Finance releases its concurrence and the necessary transitions are completed.
