AN ORDER RECONSTITUTING THE MEMBERS AND FUNCTIONS OF THE LOCAL FINANCE TEAM OF THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provided for the creation of the Local Finance Committee in every local government unit;

WHEREAS, Section 316 of the Local Government Code of 1991 specifically enumerated the composition of the Local Finance Committee such as: the Local Planning and Development Coordinator, the Municipal Budget Officer and the Municipal Treasurer,

WHEREAS, by virtue of the said code, the Local Government of Bayambang, by the authority of the Local Chief Executive, has formed its Local Finance Committee;

WHEREAS, the Local Government Unit of Bayambang, like other local government units, may expand the composition of the Local Finance Committee, identify/recognize the members of the composition, and all of its duties and responsibilities to perform;

WHEREAS, there is need to reconstitute to strengthen its capacity, update its structure, or adapt to new needs.

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby identify and reconstitute the members of the Local Finance Committee of the Local Government Unit of Bayambang, Pangasinan.

SECTION 2. Duties and Responsibilities of the Local Finance Committee

- a. Determine the income reasonably projected as collectible for the ensuing fiscal year,
- b. Recommend appropriate tax and other revenue measures or borrowings which may be required to support budget,
- c. Recommend to the Municipal Mayor the level of annual expenditures and ceilings of spending for economic, social and general services based on the approved local development plans;
- d. Recommend to the Municipal Mayor the proper allocation of expenditures for each development activity between current operating expenditures and capital outlays;
- e. Recommend to the Municipal Mayor the amount to be allocated for capital to the municipal mayor outlay under each development activity or infrastructure project;
- f. Assist the Sangguniang Bayan in the review and evaluation of budgets of the Municipality and recommend appropriate action thereon;
- g. Assist the Sangguniang Bayan members concerned in the analysis and review of annual regular and supplemental budgets of the Municipality to determine compliance with statutory and administrative requirements; and
- h. Conduct semi-annual and annual review and general examination of cost and accomplishments against performance standards applied in understanding development projects.

SECTION 3. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. REPEALING CLAUSE. All other orders, rules, regulations, and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to all Offices and Departments for their information and guidance.
