AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE ECOLOGICAL SOLID WASTE MANAGEMENT OFFICE

WHEREAS, the funds allocated for the account of the **ECOLOGICAL SOLID WASTE MANAGEMENT OFFICE-REPAIRS AND MAINTENANCE-TRANSPORTATION EQUIPMENT** is insufficient to fulfill existing obligations;
