AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE OFFICE OF THE MUNICIPAL MAYOR

WHEREAS, the funds allocated for the account of the **OFFICE OF THE MUNICIPAL MAYOR-SEMI EXPENDABLE MACHINERY AND EQUIPMENT EXPENSES AND ENVIRONMENT/SANITARY SERVICES** is insufficient to fulfill existing obligations;

WHEREAS, a total amount of ONE MILLION TWENTY-FIVE THOUSAND PESOS ONLY (₱1,025,000.00) is available to supplement the balance in the **OFFICE OF THE MUNICIPAL MAYOR- FUEL, OIL, AND LUBRICANTS EXPENSES** account, to be used for the payment of garbage disposal and purchase of equipment under the ESWMO;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, in accordance with the authority vested in me by law as the Local Chief Executive, hereby authorize Municipal Budget Officer Marie Christine B. Terrado to execute the ONE MILLION TWENTY-FIVE THOUSAND PESOS ONLY (₱1,025,000.00) as follows:
