AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE OFFICE OF THE ADMINISTRATOR AND INFORMATION AND COMMUNICATION TECHNOLOGY OFFICE

WHEREAS, the funds allocated for the account of the **OFFICE OF THE ASMINISTRATOR – OTHER BONUSES AND ALLOWANCES AND INFORMATION TECHNOLOGY OFICE – OTHER BONUSES AND ALLOWANCES** is insufficient to fulfill existing obligations;
