REORGANIZING THE COMPOSITION OF THE MUNICIPAL MANAGEMENT COMMITTEE AND FOR SUCH OTHER RELATED PURPOSES

WHEREAS, Public Office is a Public Trust. It is a settled principle of law that municipal corporations and agencies of the State for the promotion and maintenance of local self-governance and as such are endowed with the police powers in order to effectively accomplish and carry out the declared objects of its creation;

WHEREAS, Article One, Section 444 (b) (1) (x) of RA 7160, otherwise known as the Local Government Code of 1991 directs executive officials and employees of the municipality to faithfully discharge their duties and functions as provided by law;

WHEREAS, Article one, Section (b) (3) (vii) of RA 7160 states that the Municipal Mayor shall initiate and maximize the generation of resources and revenues, and apply the same to the implementation of development plans, program objectives and priorities particularly those resources and revenues programmed for agro-industrial development and country-wide growth and progress through the adoption of measures to safeguard and conserve land, mined marine, forest, and other resources of the municipality; provide efficient and effective property and supply management in the municipality; and protect the funds, credit, rights and other properties of the municipality;

WHEREAS, the Local Government Unit of Bayambang issued Executive Order No. 32 series of 2022 entitled: "Reorganizing the Composition of the Municipal Management Committee and for Such Other Purposes" on July 22, 2022, wherein the Municipal Management Committee was reorganized in order to develop, deliberate and implement development plans, program objectives and priorities of the local government;

WHEREAS, there is the need to recompose the Municipal Management Committee to add new members to replace retired employee-members to ensure that powers and functions are exercised and performed extensively for the promotion of efficient and effective delivery of services, and to promote projects and programs of the Municipality, including the protection of assets and collection of income for full utilization of resources;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby recompose the **MUNICIPAL MANAGEMENT COMMITTEE**:

SECTION 1. THE RECOMPOSED MUNICIPAL MANAGEMENT COMMITTEE.

The Municipal Management Committee of LGU Bayambang is hereby recomposed consisting of the Chairperson, a Vice-Chairperson and forty-eight (48) Members.

SECTION 2. POWERS AND FUNCTIONS. The Municipal Management Committee shall exercise powers and authority to:

- a. Formulate development plans, program objectives and priorities for resources and revenues programmed for agro-industrial development and country-wide growth and progress;
- b. Adopt adequate measures to safeguard and conserve land, mined fisheries and aquatic, forest and other resources of the municipality;
- c. Provide efficient and effective property and supply management in the municipality;
- d. Protect the funds, credits, rights and other properties of the municipality;

- e. Submit recommendations to the Bayan for appropriate measure, resolutions and ordinances;
- f. Manage, coordinate, and supervise the implementation of the development plans, program objectives and priorities, including the Sangguniang Bayan Resolutions and Ordinances;
- g. Ensure the rational use of public resources, efficiency and in accordance with law; and
- h. Exercise such other inherent, implied and incidental powers and functions as may be necessary to give effect to its main powers and authority.

SECTION 3. SECRETARIAT.

A Secretariat of the Municipal Management Committee, composed by the **OIC-Municipal Planning and Development Coordinator, MR. RICKY V. BULALAKAW** and three (3) staff designated by her, is hereby created to assist the Committee in the exercise of its functions like the recording of its proceedings, transcribing the records of the proceedings, preparation and furnishing of notices, orders, and other processes to the concerned parties and performing such other incidental and inherent administrative functions.

SECTION 4. COMPENSATION AND REMUNERATION.

The chairperson and members of the Committee as well as its Secretariat shall perform their duties as such without any additional compensation or remuneration. However, the Municipal Budget Officer is hereby directed to allocate funds for the continuous education, trainings and seminars of concerned officers and employees in Public Management.

SECTION 5. SEPARABILITY CLAUSE.

If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE.

All other orders, rules, regulations, and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY.

This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to all Offices and Departments for their information and guidance.
