#### RECONSTITUTION OF THE MUNICIPAL PROJECT MONITORING COMMITTEE (PMC) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

**WHEREAS**, DILG Memorandum Circular No. 2007-78 dated 18 July 2016 enjoins local government units to organize/reconstitute the Project Monitoring Committees (PMCs) in the local government units;

**WHEREAS**, the Department of the Interior and Local Government (DILG) Memorandum Circular (MC) 2004 – 78 dated June 22, 2004, directs the activation/reorganization of the Local Project Monitoring Committee to facilitate project implementation and devolve facilitation, problem-solving, monitoring and evaluation of foreign, national and local – funded projects to the sub-national levels;

**WHEREAS**, the Local Government Unit of Bayambang activated its Local Project Monitoring Committee through Executive Order No. 89 series 2022, dated December 20, 2022 entitled: Reorganizing the Municipal Project Monitoring Committee (PMC) of the Municipality of Bayambang, Pangasinan;

**WHEREAS**, there is the need to reconstitute the Project Monitoring Committee (PMC) for proper monitoring of implemented priority projects of the Municipality of Bayambang, Pangasinan, under the Assistance to Municipalities Program;

**NOW, THEREFORE, I, HON. MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby reconstitute and mobilize the Project Monitoring Committee in the Municipality of Bayambang:

**SECTION 2. FUNCTIONS: The Municipal Project Monitoring Committee shall:**

1. Provide and schedule all projects to be monitored to NGOs involved in project monitoring;
2. Monitor and evaluate national-funded projects including development projects funded from the Internal Revenue Allotment (IRA) share of the Local Government Units (LGUs) or supported by funds released directly to the municipality;
3. Pinpoint the problem and verify the information to be submitted for analysis and action of the development council;
4. Provide feedback on the remedial actions of the development council and follow up on their implementation; and
5. Project funded from the locally generated resources which are implemented within the respective areas.

The Municipal Planning Development Office (MPDO) shall serve as the secretariat to the Project Monitoring Committee.

The Secretariat shall prepare the M&E work program to be undertaken by the PMC during any given fiscal year which will include the list of the projects and schedule of implementation based on submission of implementing agencies, provide the Local Chief Executive with information on the projects to be monitored by the PMC and facilitate inter-agency, inter-governmental, and field headquarters coordination, if necessary.

**SECTION 3. EFFECTIVITY.**

This Executive Order shall take effect immediately and shall remain in force and effect until recalled, revised, or revoked.

All orders, rules and regulations, issuances, or any part coming from this office that is inconsistent with this order are hereby repealed, amended, or modified accordingly.
