**EXECUTIVE ORDER NO. 09**

**AN ORDER PROHIBITING THE REALIGNMENT OF FUNDS FROM MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) ACCOUNTS TO "OTHER GENERAL SERVICES" IN THE MUNICIPALITY OF BAYAMBANG AND APPLYING THE SAME POLICY TO ALL DEPARTMENTS AND UNITS**

**WHEREAS**, the Municipal Government of Bayambang is committed to ensuring transparency, accountability, and fiscal discipline in the management and utilization of public funds;

**WHEREAS**, the Maintenance and Other Operating Expenses (MOOE) class is intended to fund essential and specific operational needs of each department and office, as programmed and authorized in the Annual Investment Plan (AIP), Local Expenditure Program (LEP), and Annual Budget;

**WHEREAS**, "Other General Services" is used to record the cost of other general services contracted by the municipality not otherwise classified under any of the specific general services accounts, which, if unregulated, may undermines the integrity and specificity of budget planning and execution;

**WHEREAS**, there is a need to enforce stricter guidelines in the realignment of budget items to ensure that appropriations are used according to their original purpose and to prevent indiscriminate fund transfers;

**NOW, THEREFORE**, I, Mary Clare Judith Phyllis Jose-Quiambao, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. PROHIBITION OF REALIGNMENT TO "OTHER GENERAL SERVICES"**

No realignment of appropriated funds from any Maintenance and Other Operating Expenses (MOOE) account to the "Other General Services" account thru an Executive Order shall be allowed in the Municipality of Bayambang.

**SECTION 2. COVERAGE**

This Executive Order shall apply to all departments, units, and special bodies under the Municipal Government of Bayambang, including budgetary proposals and requests for realignment submitted during the current and succeeding fiscal years.


### **SECTION 4. SEPARABILITY CLAUSE**
