EXECUTIVE ORDER NO. 19

AN ORDER MANDATING THE UTILIZATION OF BARANGAY FACILITIES WITHIN THE MUNICIPALITY OF BAYAMBANG BY THE DSWD FOR THE IMPLEMENTATION OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps), SUSTAINABLE LIVELIHOOD PROGRAM (SLP), AND RELATED SOCIAL WELFARE INITIATIVES.

WHEREAS, the Local Government Code of 1991 mandates that Local Government Units (LGUs) shall ensure the delivery of basic services and facilities, including social welfare services;

WHEREAS, the Pantawid Pamilyang Pilipino Program (4Ps) and the Sustainable Livelihood Program (SLP) are flagship poverty reduction strategies of the national government, implemented through the Department of Social Welfare and Development (DSWD) in close coordination with the Municipal Social Welfare and Development Office (MSWDO);

WHEREAS, the successful implementation of these programs relies heavily on the regular conduct of Family Development Sessions (FDS), community engagements, and case management activities which require accessible, safe, and stable venues within the respective Barangays;

WHEREAS, during the Partnership Meeting with Civil Society Organizations (CSOs) on October 02, 2025, and the subsequent Municipal Advisory Council Meeting on October 27, 2025, significant logistical constraints were identified regarding the inconsistent availability and accessibility of Barangay facilities for these purposes;

WHEREAS, there is an urgent need to establish a unified municipal directive to ensure that program implementers and beneficiaries have unimpeded access to community spaces to maximize the impact of social welfare services;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. MANDATORY UTILIZATION OF BARANGAY FACILITIES.

All Punong Barangays and Barangay Officials within the Municipality of Bayambang are hereby directed to authorize and prioritize the use of Barangay Halls, Multi-Purpose Centers, and other covered courts or facilities for the activities of the DSWD - Pantawid Pamilyang Pilipino Program (4Ps) and the Sustainable Livelihood Program (SLP).

SECTION 2. SCOPE OF ACTIVITIES.

The facilities shall be made available for, but not limited to, the following:

Regular Family Development Sessions (FDS);

Sustainable Livelihood Program (SLP) orientations and skills training;

Beneficiary validation and payout activities;

Meetings conducted by Program Implementers, Case Managers, and accredited Civil Society Organizations (CSOs) related to these programs.

SECTION 3. COORDINATION AND SCHEDULING.

To ensure orderly use, Bayambang Municipal Operations Office shall provide the Barangay Council with a monthly schedule of activities coordinated by the case managers and program implementers. The Barangay shall ensure the venue is available, clean, and ready for use at the designated times.

SECTION 4. PROHIBITION OF FEES.

In the spirit of public service and inter-agency cooperation, the use of these facilities for the aforementioned social welfare programs shall be free of charge, provided that the DSWD exercise due care in maintaining the cleanliness and integrity of the facilities.

SECTION 5. COMPLIANCE.

Failure to comply with the provisions of this Order may be subject to administrative action/discipline in accordance with existing laws and local regulations regarding the performance of official duties.

SECTION 6. SEPARABILITY CLAUSE.

If any provision of this Order is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 7. EFFECTIVITY.

This Executive Order shall take effect immediately.
