#### RE-ORGANIZING THE LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) MUNICIPAL AWARDS COMMITTEE OF BAYAMBANG, PANGASINAN

**WHEREAS**, Executive Order No. 394 dated January 22, 1997 established the Lupong Tagapamayapa Incentives Awards (LTIA) which aims to accord official recognition and tribute to Lupons for reasons of exemplary performance in the implementation of the Katarungang Pambarangay;

**WHEREAS**, DILG Memorandum Circulars No. 2008-102 as enhanced by DILG MC No. 2016-58, DILG MC No. 2023-022 and DILG MC No. 2025-007 provides for the guidelines for the Lupong Tagapamayapa Incentives Award (LTIA);

**WHEREAS**, the Lupong Tagapamayapa Awards Committee at the municipal, city, provincial, regional, and national levels are also created as provided for in the EO 394;

**WHEREAS**, it is necessary to reorganize the Lupong Tagapamayapa Incentives Awards (LTIA) Municipal Awards Committee in order to provide it with a renewed mandate and to refresh its membership;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the reorganization of the LTIA Municipal Awards Committee of Bayambang, Pangasinan, as follows:

1. Initiate and coordinate necessary activities for the successful implementation of the Awards;
2. Disseminate the guidelines and criteria for the selection of winners;
3. Conduct assessment of the Katarungang Pambarangay implementation of the component barangays of the municipality;
4. Submit to the Provincial Awards Committee (PAC) the result of the Municipal Assessment;
5. May secure funding and counterpart prizes from the partner agencies and the private sectors; and
6. May plan and implement appropriate awarding ceremonies

**Section 3. ALLOCATION OF FUNDS.** Expenses to be incurred for the conduct of the assessment of component barangays shall be charged against the Municipal Katarungang Pambarangay (KP) fund.

**Section 4. EFFECTIVITY.** This Executive Order shall take effect immediately.
