**AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER PLAZA, PARKS,
 AND MONUMENTS**

WHEREAS, the funds allocated for the account of the **REPAIRS AND MAINTENANCE – LAND IMPROVEMENTS** is insufficient to fulfill existing obligations;

WHEREAS, a total amount THREE HUNDRED TWENTY-ONE THOUSAND EIGHT HUNDRED PESOS ONLY (₱321,800.00) is available to supplement the balance in the **REPAIRS AND MAINTENANCE – BUILDINGS AND OTHER STRUCTURES, REPAIRS AND MAINTENANCE – INFRASTRUCTURE ASSETS, AND REPAIRS AND MAINTENANCE – MACHINE EQUIPMENT** account, to be used for the Rehabilitation of Municipal Plaza Phase I.

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, in accordance with the authority vested in me by law as the Local Chief Executive, hereby authorize the Municipal Budget Officer, Marie Christine B. Terrado to execute the transfer amount THREE HUNDRED TWENTY-ONE THOUSAND EIGHT HUNDRED PESOS ONLY (₱321,800.00) as follows:
