AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER OFFICE OF THE SPECIAL ECONOMIC ENTERPRISE

WHEREAS, the funds allocated for the account of the **SPECIAL ECONOMIC ENTERPRISE – REPAIRS AND MAINTENANCE – INFRASTRUCTURE ASSESTS** is insufficient to fulfill existing obligations;

WHEREAS, a total amount **TWO HUNDRED TEN THOUSAND PESOS ONLY (P210,000.00)** is available to supplement the balance in the **SPECIAL ECONOMIC ENTERPRISE – REPAIRS AND MAINTENANCE – BUILDING AND OTHER STRUCTURES** account, to be used for the improvements of Old Bayambang Central School;

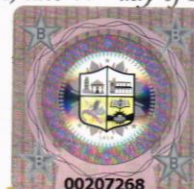
