**AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER OFFICE OF
THE MUNICIPAL MAYOR**

WHEREAS, the funds allocated for the account of the **OTHER SUPPLIES AND MATERIALS EXPENSES AND REPAIRS AND MAINTENANCE – TRANSPORTATION EQUIPMENT** is insufficient to fulfill existing obligations;
