**AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER OFFICE OF
THE MAYOR**

WHEREAS, the funds allocated for the account of the **REPAIRS AND MAINTENANCE - BUILDING AND OTHER STRUCTURES** is insufficient to fulfill existing obligations;

WHEREAS, a total amount of ONE HUNDRED NINETY-FIVE THOUSAND FIFTY-FIVE PESOS ONLY (P195,055.00) is available to supplement the balance in the **REPAIRS AND MAINTENANCE - INFRASTRUCTURE ASSETS** account, to be used for the purchase of electrical materials for wiring works of Automatic Transfer Switch at the Municipal Building;
